LMF Special Data and Ai Market Breakfast 6th March 2025

Generative Ai and the Speciality Market

At the LMF AI & Data London Market Breakfast, Market leaders explored AI's growing role in underwriting, broking and claims. Hosted with Snowflake, the event highlighted AI's potential to transform specialty insurance through advanced data analytics.

Key discussions

Snowflake's Head of Insurance, Sully McConnell, who was the former Chief Data Officer at The Hartford, emphasised the shift from traditional data platforms to AI-driven insights. Live polling revealed that most Market firms are experimenting with AI in limited areas, primarily for internal automation. Key challenges include data quality, regulatory concerns, and a lack of expertise.



Discussions also focused on AI's future impact on underwriting and risk modeling to fraud detection. Attendees agreed on the need for quick "safe" wins before large-scale AI adoption and emphasised the need for cross-market collaboration, as a key to success.

Legacy 2.0 Summit 20th March 2025

Bringing the Market together - let's talk legacy

On 20 March 2025, LMF and Aon hosted Legacy 2.0 at the Bishopsgate Institute, bringing together underwriters, reinsurers, and market leaders to discuss trends in legacy and run-off transactions. With the global non-life run-off reserves exceeding \$1 trillion, much of which is within the UK and Ireland, the legacy scene is most active. This new conference for the Market explored how firms are leveraging legacy solutions for capital optimisation.



Key discussions

A fireside chat with Rachel Turk (CUO, Lloyd's) and Dominic Christian (Global Chairman, Aon RS) on Lloyd's Oversight Principles, a Cedants' Panel revealing strong market appetite for legacy deals, and a Buyers' Panel featuring RITC firms discussing transaction trends. Live polling showed 85% of firms are considering a legacy deal within the next 12-24 months.

The event concluded with a networking reception in the Bishopsgate Institute's historic library, featuring one of the largest collections of LGBTQ+ literature. LMF is grateful to the Legacy Team at Aon Reinsurance Solutions for partnering on this important event.

Support Dogs is a national charity, dedicated to **saving and improving** the lives of children and adults living with some of the **most challenging medical conditions**. Entirely based in **Sheffield** we train specialist assistance dogs that allow our clients to live a **more independent and socially inclusive life**.

We currently have three different programmes for which our support dogs are trained: **autism assistance, physical disability assistance, and epilepsy seizure alert**.



DISABILITY ASSISTANCE

Our disability assistance dogs are trained to **improve independence for people with physical disabilities**, working with clients whose conditions include **MS, cerebral palsy, fibromyalgia and spinal cord injury**.

We specialise in training a client's own pet dog to provide this support. This includes **raising an alarm** in an emergency, **opening and closing doors, picking up objects, assisting with dressing and undressing**, and more tasks **tailored to the individual**.



EPILEPSY SEIZURE ALERT

Epilepsy is one of the **most common neurological illnesses** with more than **600,000 cases in the UK**. In some cases, seizures **can't be controlled** with medication and can happen at any time. This makes the simplest tasks **incredibly dangerous**.

Our seizure alert dogs provide a **100% reliable** warning up to **1 hour in advance of an epileptic seizure**, providing safety and independence to their human.

We are the only charity in the UK providing this service.



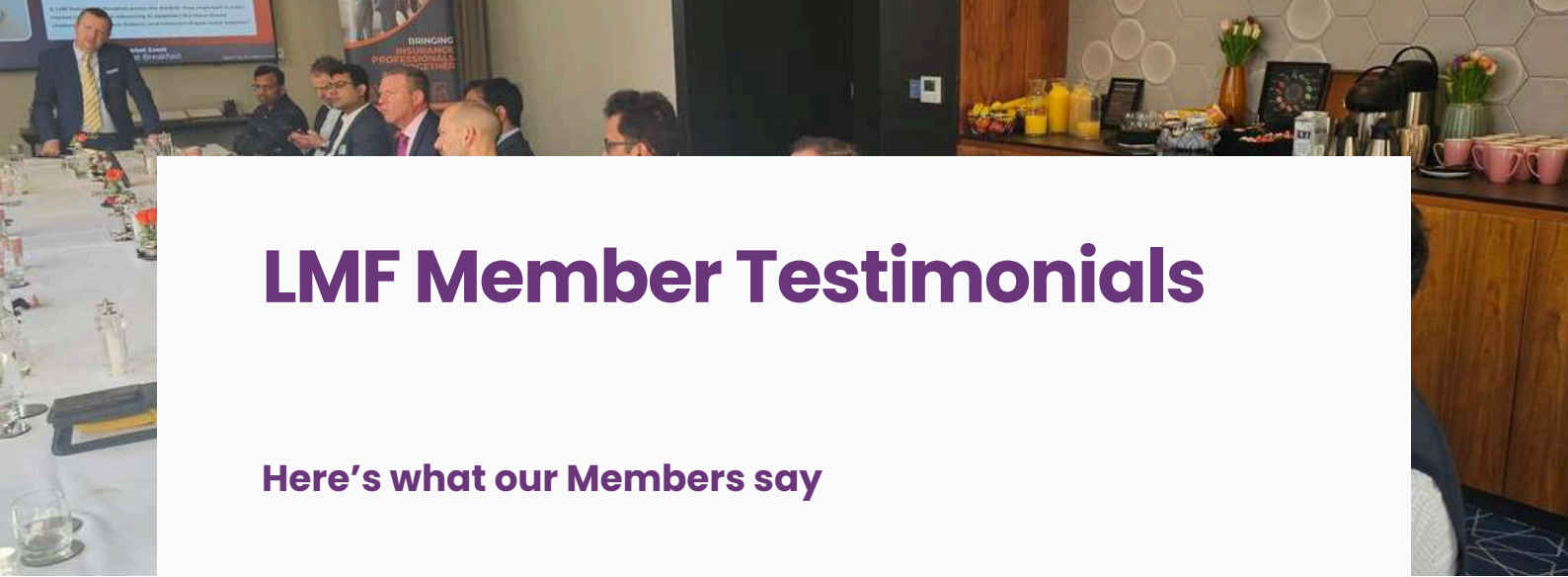

Autism Assistance Dogs are trained to provide **safety** and to **facilitate a more independent and socially inclusive life** for both the autistic child and their family.

Support Dogs trained the UK's first autism assistance dog in 2008 and demand for this service has increased by over 400% over the past five years.

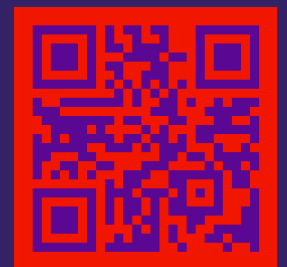
